### **I. Assessment, Treatment and Management of Child Pornography Offenders**

**Presenter: Michael Seto**

There is increasing public and professional concern about child pornography offenders, paralleling a dramatic increase in the number of cases seen in clinical and criminal justice settings. Much of this offending appears to be internet-facilitated. In this workshop, Dr. Seto will review recent research on the characteristics and risk of recidivism posed by child pornography offenders. He will integrate these findings with the established literature on contact sexual offenders in order to make recommendations about clinical practice regarding the assessment, treatment and management of child pornography offenders.

#### **About the Presenter: Michael Seto, Ph.D.**

Dr. Seto received his Ph.D. in Psychology from Queen's University in Kingston, Canada. He is a registered clinical psychologist and is currently employed as a consultant with the Royal Ottawa Health Care Group. He has adjunct professor appointments at the University of Toronto, Ryerson University, Carleton University, and the University of Ottawa. Dr. Seto has published extensively on pedophilia, child pornography, sexual offending, and risk assessment, and regularly presents at scientific meetings and professional workshops on these topics. He recently authored a well-reviewed book on pedophilia and sexual offending against children, *Pedophilia and Sexual Offending Against Children: Theory, Assessment, and Intervention*, published by the American Psychological Association in 2008.

### **II. Introduction to Motivational Interviewing**

**Presenter: David Prescott, LICSW**

Motivational interviewing is a collaborative, person-centered form of guiding to elicit and strengthen motivation for change. It has received considerable research support in a number of settings. This workshop will review research related to Motivational Interviewing and what works in treatment with sexual abusers of all ages. Participants will practice Motivational Interviewing skills in a supportive and enjoyable atmosphere.

#### **About the Presenter: David Prescott, LICSW**

Mr. Prescott has worked in and around inpatient settings since 1984, and specifically with individuals who have sexually abused since 1987. He currently serves as Clinical Director for the Becket Family of Services, which provides treatment for troubled youth in Maine and New Hampshire. Prior to his move to New England, he served as the Clinical Director at the Minnesota Sex Offender Program and Treatment Assessment Director at the Sand Ridge Secure Treatment Center in Wisconsin. Mr. Prescott has published articles on risk assessment, interviewing, and providing residential treatment to youth, and Mr. Prescott is the author, editor, and co-editor of recent books on people who have sexually abused. He is the Immediate Past President of ATSA; a charter member of the International Association for the Treatment of Sex Offenders; and has also served on the board of directors for Stop It Now! Mr. Prescott is also a member of the Motivational Interviewing Network of Trainers (MINT), an international organization devoted to a client-centered, directive method for enhancing intrinsic motivation to change by exploring and resolving ambivalence.

#### *TUESDAY KEYNOTE & PLENARY PRESENTER*

#### **DR. LAWRENCE ELLERBY**

Dr. Lawrence Ellerby has been involved in the development and delivery of programs for the assessment and treatment of violent and sexual offenders since 1987. His private practice, Forensic Psychological Services conducts forensic evaluations and provides institutional and community based treatment, specializing in services for high risk/high need offenders. Lawrence is a consultant to the Canadian Center for Child Protection, a trainer for the Canadian Police College and an observer/non-law enforcement member of the Interpol Specialist Group on Crimes Against Children. He is also currently serving as the President of the Board of Directors for ATSA. Lawrence is a Lecturer for the Department of Psychiatry at the University of Manitoba, has published articles and book chapters related to offender assessment, treatment and risk management and has given invited addresses on these topics in Canada, the United States and Europe. He is also a past recipient of the Canadian Criminal Justice Association's National Crime Prevention Award for his practice's innovative contributions to sexual offender treatment. Most importantly, he comes from Winnipeg Manitoba, Canada, has an amazing 25 year old daughter who is much smarter than him, a wife who works in the field and keeps him on his toes and an insecurely attached dog, named Jake.
